We're All Victims of the Obama Dream Act Amnesty

Known officially as the "Consideration of Deferred Action for Childhood Arrivals Process," it is more than the Orwellian Newspeak term "Deferred Action" suggests. It is a way to give millions of illegal aliens work permits. In fact it *requires* the illegal alien to apply for a work permit.¹

From the U.S. Citizenship and Immigration Service website:

To request consideration of deferred action for childhood arrivals from USCIS, you must submit Form I-821D, Consideration of Deferred Action for Childhood Arrivals to US-CIS. This form must be completed, properly signed and accompanied by a Form I-765, Application for Employment Authorization, and a Form I-765WS, Worksheet, establishing your economic need for employment. If you fail to submit a completed Form I-765 (along with the accompanying filing fees for that form, totaling \$465), USCIS will not consider your request for deferred action.

Prop 200 won with 57 percent of the vote. It is *mandatory* that the applicant submit a completed Form I-765 Application for Employment Authorization (a work permit) along with the original I-821D.

The purpose of this Dream Act Amnesty is to give illegal aliens work permits, which will put them into direct competition with American citizens and legal immigrant workers!

This seems, at first, counterintuitive. But not when one considers the demographics of the nation.

The desire for massive legal and illegal immigration into our country comes down to one thing: customers. Regardless of everything else, it is customers that are wanted, and needed, and that is why the borders are unsecured and the law continually ignored.

The post-World War II Baby Boomers, once the fiercest consumers on the planet, are rapidly aging out of the consuming cycle. Retiring at a rate of 10,000 per day, they need to be replaced. The youngest turn 50 years old in 2014, an age where consumption begins to rapidly decline. By age 54, in 2018, the last of the Baby Boomers will be at an age where they are pretty much out of the consuming cycle. A roar of laughter went up from the audience, so loud you would have thought I was the biggest ass in Alameda County. And, I let them laugh. When the laughter died down I paused and looked around the room and said, "I know that sounds naïve *today*. But, we believed that...*then*." And you could have heard a pin hit the carpet.

There have been in the past, and will be in the future, numerous examples of how our law-abiding culture is devolving into the corruption we see in so many third-world countries. But, as Americans see the corruption expand, and do not see the institutions of our society stop it and punish the law breakers, cynicism will eventually grow as faith in the system fades.

And the loss of faith in America is probably the worst victim story of all. \blacksquare
